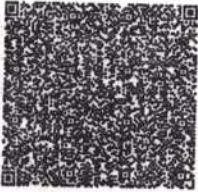

Inclusion of the restrictions mentioned in the Government Order dated 30-11-1991 in the Trust-

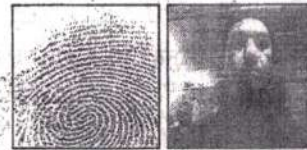





- 4.01 That the settler Mr. M. S. Faridi, Mrs. Arshi Zafar will be the life time member of the trust. - 4.05 **EFFECT OF APPOINTMENT OF NEW TRUSTEES:** Upon every appointment made in pursuance of the last fore going clauses thereof the newly appointed trustees shall have all powers and authorities of the outgoing trustees under THESE PRESENTS.
- 5.01 **POWER TO APPOINT AGENTS AND COMMITTEES:** The Board of trustees shall be entitled from time to time to appoint with or without remuneration and on such terms and conditions as they may think proper to function under the authority and control of the trustees for carrying out the trust of These Presents or the management there of and may within the limits of their own powers invest them with all such powers including power to incur all such expenditure as may be necessary for carrying out the objects of the trust.

5.02 POWER TO PURCHASE, HIRE OR TAKE ON LEASE: The board of trustees shall be entitled to purchase or hire or to take on lease or to sell or let out or construct/ developed a property or properties for the purpose of the trust here by created.
